## Agile legal services for disruptive altnet

#### About Digital Infrastructure

## The challenge

While the launch of Digital Infrastructure caused quite a stir when the brand – and its sister company, Internet Service Provider BeFibre – fully hit the market in 2022, the altnet's story had actually begun the previous year.

With access to £100m of private funding from Basalt Infrastructure Partners, Digital Infrastructure's goal was to be a new generation network operator on a mission to deliver full fibre connectivity to approximately 1 million premises, by 2027. And headline after headline was soon published, detailing the intricacies of the firm's symmetrical network, which promises download and upload speeds up to 13 times faster than the UK's more commonplace Fibre-to-the-Cabinet (FTTC) coverage\*.

Agility is core to Digital Infrastructure's ambitious plans to future-proof the UK's connectivity and build a brand-new network that will leave a positive legacy in society. So, when it came to securing an outsourced legal partner who could deliver commercially robust, sector-specific expertise, the team contacted Trenches Law.

## The solution

Appointed in the summer of 2021 when Digital Infrastructure's business journey was only just beginning, Trenches Law became the altnet's retained legal counsel. Responsible for everything from contracts to privacy policies, the negotiation of T&Cs, and anything else which falls under the commercial law umbrella, Trenches Law quickly became embedded within the Digital Infrastructure team.
